### **IPA ANNUAL TRAINING PLAN 2025**

#### I. INTRODUCTION

The IPA Annual Training Plan 2025 of the MEA Training Centre has been prepared on the basis of the needs established with the conducted the Training Needs Assessment (TNA) in December 2023 and in line with the Training Programme – 2024-2025, entailing the IPA Structure and Territorial cooperation Programmes.

The IPA Annual Training Plan 2025 provides a detailed overview of the training modules to be implemented in 2025 with the purpose of further development of capacities of the relevant staff of the state and public administration involved in the implementation of the IPA and Territorial Cooperation Projects and Programmes, and where needed – the end beneficiaries, and the EU integration process of the Republic of North Macedonia.

The Training Plan foresees providing trainings at basic and/or induction level as well as at advanced level of the participants. The planned training events would be conducted either in online form or with physical presence of the target group. More detailed information about the content of each thematic area and training modules can be found in the Training Programme 2024-2025. The funding and delivery of the capacity building events which are part of this training plan shall be secured through the MEA Training Centre and financially supported by MEA, as well as through EU funds, i.e. projects, and other donor assistance.

In the course of 2025, a pool of trainers of MEATC shall be established through the regular government procedure, followed by a public call and a recruitment process. These efforts are complementary to and with the donor programmes and cooperation that is already in place, or that might be developed meanwhile. Consequently, it is expected that this Annual Training Plan of MEA Training Centre is enriched and modified throughout the calendar year.
